The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

General Statement(s):


1. Delete all text throughout the label marked with "strikethrough."
2. The active product name for the referenced product has been changed from "**NEW FORMULA RAID FLYING INSECT KILLER**" to "**RAID FLEA KILLER**."
3. The revised basic and alternate CSFs (dated September 7, 2012) submitted along with this amendment to change the active product name from "**NEW FORMULA RAID FLYING INSECT KILLER**" to "**RAID FLEA KILLER**" are acceptable.

Should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under section 12(a)(1)(E) of FIFRA. 40 CFR §156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not be substantially differ from those claims approved through the registration process. As an alternative, you may refer consumers to the company's phone number or e-mail address.

Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA.
