- The registration for this product is being issued with the understanding that certain defects in the labeling which are noted below will be corrected as soon as possible. Objection is not raised to the use of the present labeling for a reasonable period of time while fully corrected labeling is being prepared. Five copies of the corrected labeling must be submitted.
- 1. Methyl Salicylate is considered to be active and should be so declared.
- 2. Sodium metasilicate is considered to be inert in phenolic type formulations and should be so declared.
 - 3. The term "Toilet Bowl" should be replaced by wording such as "Toilet Seat."
 - 4. The claim "....disinfect all bathroom surfaces" should be revised as "..... disinfect most bathroom surfaces."
 - 5. The front panel precautionary labeling must meet the type size and prominence requirements.
 - 6. A hyphen should follow orthophenyl.
