

**DIRECTIONS FOR USE:** Do not spray up into air. Point spray opening toward cracks, crevices, along baseboard, doors and windowsills. Spray in inaccessible areas behind stoves, refrigerators and around garbage cans. Hold about 12" from the surface being treated. Spray until wet. Avoid excessive wetting of asphalt, tile, rubber, and plastic. Do not spray open floor areas, furniture, beds or bedding.

**ANTS:** Apply to ant trails, around doors, windows, and wherever ants enter house. Do not treat entire area of floor, or floor covering. Repeat as necessary.

**ROACHES, WATERBUGS:** Spray until wet in cracks, around baseboards and other hiding places. Repeat as necessary.

**silverfish, Crickets, Spiders:** Spray infested areas as recommended under directions for use. Repeat as necessary.



## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CAUTION:** Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist and contact with eyes, skin, or clothing. Do not smoke while using. Provide adequate ventilation of area being treated. Do not apply to humans, pets or plants or contaminate feed, foodstuffs, dishes or utensils. Cover and avoid spraying fish aquariums. Do not allow children or pets in treated areas until surfaces are dry. Wash hands thoroughly with soap and water after use. Wash contaminated clothing before reuse. Keep out of reach of children.

### STATEMENT OF PRACTICAL TREATMENT

**IF SWALLOWED:** Do not induce vomiting. Call a physician or Poison Control Center.

**IF INHALED:** Remove to fresh air.

**IF ON SKIN:** Wash promptly with soap and water.

**IF IN EYES:** Flush eyes with plenty of water. Call a physician immediately.

**NOTE TO PHYSICIAN:** Product contains petroleum distillate and cholinesterase inhibitors - atropine is antidotal and should be administered only after symptoms appear.

### ENVIRONMENTAL HAZARDS

Do not contaminate water disposal of wastes. This pesticide is toxic to fish, birds and wildlife. Do not apply to water.

### PHYSICAL OR CHEMICAL HAZARDS
