DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USING: Hold container upright. Point spray opening away from face and press button.

FLIES, MOSQUITOES, SMALL FLYING MOTHS, GNATS: Most effective when sprayed directly on flies. You can clear entire room in minutes by spraying upwards in sweeping movement (4 seconds for average room of 1000 cubic feet) staying about 3 feet from walls, fabrics and furniture. Keep doors and windows closed for about 15 minutes. Do not remain in treated area. Ventilate after treatment.

ROACHES, WATERBUGS, SILVERFISH, CRICKETS, ANTS, SOW-BUGS: When this product is primarily a flying insect killer, tests prove that it is effective when spraying directly on these crawling insects. Spray in places where crawling insects are known to crawl or hide. Spray insects directly when possible. Repeat as necessary.

STORAGE: Store in an area inaccessible to children.

DISPOSAL: Wrap container securely in paper and discard in trash. Do not puncture or incinerate.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS & DOMESTIC ANIMALS CAUTION:

Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors or spray mist. Avoid contact with skin, eyes or clothing.
