RAID ANT AND ROACH KILLER

Do not spray near open flame. So not smoke while using.

- Kills insects on contact
- Keeps on killing with residual action even after it dries
- Penetrating vapor reaches bugs through cracks and crevices - kills them where they hide
- Soft spray that doesn't bounce
- Kills even resistant roaches

DIRECTIONS FOR USE

Point valve opening toward surface to be sprayed and press button firmly. Hold container about 12" from the surface being sprayed. Spray until surfaces are wet. Avoid excessive wetting of asphalt tile, rubber and plastic materials.

ANTS: Apply to ant trails; also around doors, windows and wherever ants enter house. Repeat as necessary.

ROACHES, WATERBUGS: Spray until wet in cracks, around baseboards, and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

For other crawling insects like Silverfish, Crickets and Spiders, spray areas infested by these pests. Repeat as necessary.

NOT A SPACE SPRAY - APPLY AS A SURFACE SPRAY ONLY

CAUTIONS: Harmful if swallowed, inhaled or absorbed through skin. If swallowed, induce vomiting. Get immediate medical attention - Atropine in

antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine. Avoid breathing spray mist. Do not apply to humans. Avoid contact with skin, eyes, or clothing. Wash hands thoroughly with soap and water after use and before eating or smoking. Do not smoke while using. Keep out of reach of children: do not allow children in treated areas until dry.

Do not use in commercial food preparation areas or in edible productss areas of food processing plants. Provide adequate ventilation of area being treated. Do not spray more that 1 1/2 minutes in average room. Do not apply to pets or contaminate feed, foodstuffs, dishes or utensils.

Contents under pressure. Never set container on stove, radiator or place where temperature will exceed 120 F. which may cause container to burst. Do not puncture or throw container into fire.

Remove birds and cover fish bowls when spraying. Do not allow pets on treated areas until dry.
