Subject: Revised Labeling - Crack and Crevice Use Pattern Raid Liquid Ant and Roach Killer EPA File Symbol 4822-110 Your Submission Dated November 1, 1990

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided that you make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

1. Format the Ingredients Statement as follows:

- 2. Under Precautionary Statements, change "Wash thoroughly with water after use before or smoking." to "Wash hands thoroughly with soap and water after use and before eating or smoking.
- 3. Under Directions for Use, change "Hold container about 12" the surface being treated." to "Hold container about 12" from the surface being treated."
 - 4. Add the heading STORAGE AND DISPOSAL before "Storage."
- 5. The Note to Physician should appear at the end of the Statement of Practical Treatment.
