

DIRECTIONS FOR USE

Point spray dispenser toward surface to be sprayed. Hold spray dispenser about 12" from the surface and spray until wet. Avoid excessive wetting of asphalt tile, rubber and plastic materials. After each use remove spray dispenser and replace container cap.

ANTS: Apply to ant trails; also around doors, windows and wherever ants enter house. Repeat only as necessary.

ROACHES, WATERBUGS: Spray until wet in cracks, around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat only as necessary.

For other crawling insects, Silverfish, Crickets. and Spiders, spray areas infested by these pests. Repeat only as necessary.

NOT A SPACE SPRAY - APPLY AS SURFACE SPRAY ONLY

CAUTIONS: Harmful if swallowed, inhaled or absorbed through skin. If swallowed, get immediate medical attention. Atropine is antidotal. Avoid breathing spray mist. Avoid contact with skin, eyes or clothing. Do not smoke while using. Provide adequate ventilation of area being treated. Do not spray more than 1 1/2 minutes in average room. Do not apply to humans, pets or contaminate feed, foodstuffs, dishes or utensils. Spills should be cleaned up immediately with soap and water, avoiding contact with hands. Wash hands thoroughly with soap and water after use, and before eating or smoking. Do not allow children or pets on treated areas until dry. Keep out of reach of children. Remove birds and cover fish bowls when spraying. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not spray on plants or shrubbery.

Do not reuse empty container. Wash thoroughly with water and detergent. Discard in a safe place.
