The proposed amendment to the registration of the product cited above under the Federal Insecticide, Fungicide, and Rodenticide Act removing the active ingredient, MGK R-11, is acceptable subject to the comments listed below. A stamped copy of the label is enclosed for your records.

- Provide the chemical identity of all components of the perfume, H&R 47455D. Include the Chemical Abstracts Service Registry Number and the percentage of each component in the mixture. Two copies of the Material Safety Data Sheet for the perfume must also be submitted.
- Submit the following acute toxicity data on the new formulation.
 This data must be submitted within 9 months of the date of this letter.
 - a. Acute oral toxicity
 - b. Acute dermal toxicity
 - c. Acute inhalation toxicity
 - d. Primary eye irritation

- 3. Submit a 1-year storage stability study. The formulated product must be analyzed for its active ingredients at time zero and during a year of storage. The storage must be under warehouse conditions of temperature and bumidity using containers similar to those which will be used in the trade. This data must be submitted within 15 months of the date of this letter.
- 4. Provide the flashpoint of this product with the propellent or add "Extremely Flammable" to the Physical and Chemical Hazards statement.
- Add the statement "Do not puncture or incinerate" to the Disposal statement.
