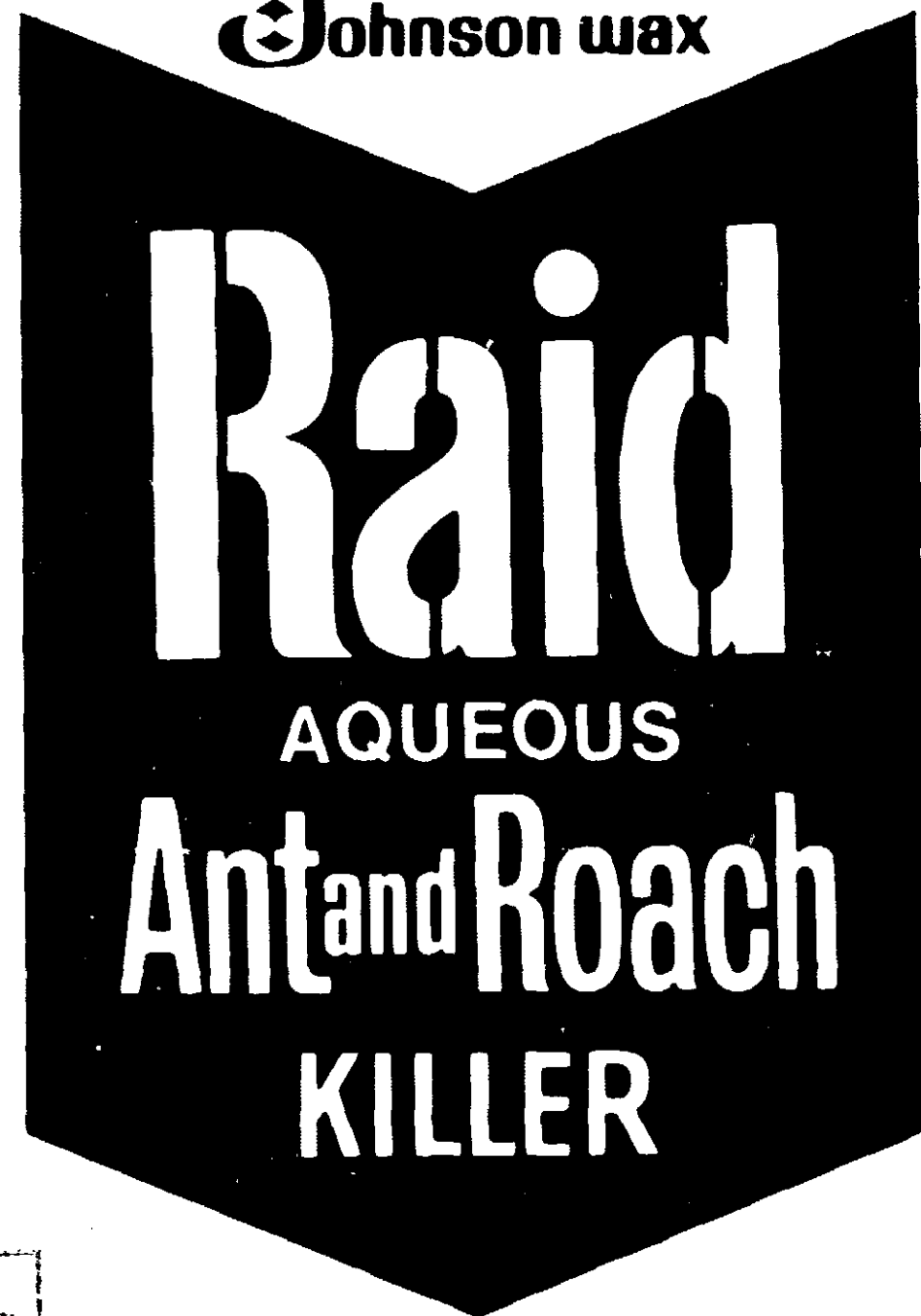

HOLD AS UPRIGHT AS POSSIBLE WHEN SPRAYING
RAID AQUEOUS ANT AND ROACH KILLER

- Kills insects on contact
- Keeps on killing with residual action even after it dries

NOT A SPACE SPRAY-APPLY AS A SURFACE SPRAY ONLY

DIRECTIONS: Shake Before Use

Point valve opening toward surface to be sprayed and press button firmly. Hold container about 12" from the surface being sprayed. Spray until surfaces are wet. This product is formulated as a coarse, wet spray capable of producing an insecticidally active residue.

ANTS. Apply to ant trails; also around doors, windows and wherever ants enter house. Repeat as necessary.

ROACHES, WATERBUGS: Spray until wet in cracks, around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

For other crawling insects like Silverfish, Crickets, and Spiders, spray areas infested by these pests. Repeat as necessary.

CAUTION: Harmful if swallowed, inhaled or absorbed through skin. If swallowed, get immediate medical attention—
 Note to Physician: Atropine is antidotal and should be administered only after symptoms appear. Avoid breathing spray mist. Do not apply to humans. Avoid contact with skin, eyes or clothing. Wash hands thoroughly with soap and water after use, and before eating or smoking. Do not smoke while using. Keep out of reach of children; do not allow children in treated areas until dry. Do not use in edible products areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

Remove birds and cover fish bowls when spraying. Do not allow pets on treated areas until dry. Do not spray on plants or shrubbery.

WARNING: Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperatures above 120°F may cause bursting. Never throw container into fire or incinerator.

ACTIVE INGREDIENTS: 0.0-diethyl-0-3,5,6-trichloro-2-pyridyl phosphorothioate, 0.25%; pyrethrins, 0.08%; technical piperonyl butoxide, 0.40% (equivalent to 0.32% of (butylcarbityl) (6-propyl piperonyl) ether and 0.08% related compounds), petroleum distillate, 0.46%
