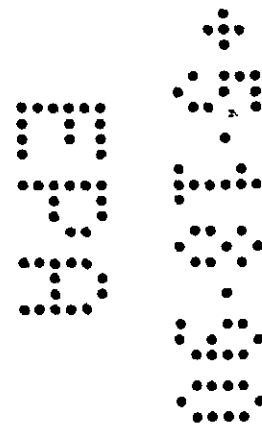

SPRAY PET BEDDING

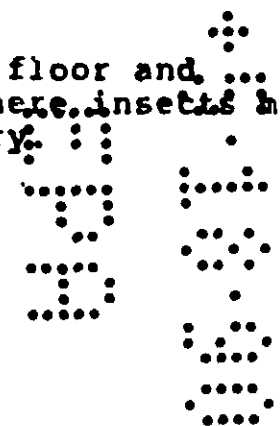
FLEAS: Remove soiled pet bedding and clean thoroughly or destroy. Spray sleeping quarters of pets, around baseboards, windows, door frames, wall cracks and floors. Spray localized areas of floor and floor coverings. Spray surface to slight dampness. Repeat as necessary. Do not spray animals. Put fresh bedding in pet's quarters after spray has dried. Additionally, treat pets with an E.P.A. approved product registered for pet use. Use Raid Flea Killer in conjunction with Raid Indoor Fogger for particularly heavy flea infestations for a complete flea protection program.

ANTS: Apply to ant trails, also around doors, windows, and wherever ants enter house. Repeat as necessary.

ROACHES, WATERBUGS: Spray until wet in cracks, around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

TICKS, SILVERFISH, CRICKETS, AND SPIDERS: Spray areas infested by these pests. Repeat as necessary.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Hit as many insects as possible. Repeat as necessary.

DISPOSAL:
