Pyrethrin's fast knockdown and powerful effectiveness keeps on killing roaches even after it dries instead of fading away in less than a day — Yet it's alright to spray in the air. The high-activity mist kills flying insects in the air on contact, and the tracer foam surface spray kills roaches and ants on contact and keeps on killing with residual action.

**DIRECTIONS: SHAKE BEFORE USING.**

Point actuator opening away from face and push button, holding can as upright as possible. Do not use on edible fruits or vegetables.

**FOR FLYING INSECTS:** Flies, mosquitoes, flying moths, gnats, wasps. Close doors and windows and spray up into air with a sweeping motion. Keep about 3 feet from walls, fabrics, furniture. Keep room closed 15 minutes. Six seconds spraying clears average size room (1000 cu. ft.). Also spray surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

**FOR CRAWLING INSECTS:** Hold dispenser about 12 inches or less from surface being sprayed. Spray until surface is wet. Foam tracer shows where you have sprayed and will disappear when the product dries. **ROACHES, WATERBUGS, CRICKETS, SILVERFISH, CENTIPEDES, SCORPIONS, SPIDERS, SOWBUGS:** Spray thoroughly into hiding places such as cracks and crevices, around pipes and baseboards. Hit as many bugs as possible. Repeat as necessary. **CARPET BEETLES:** Spray top and underside of rugs. Repeat as necessary. **BED BUGS:** Remove bedding and spray mattress, seams, folds and other hiding places in bed and room. Repeat as necessary. **FLEAS:** Spray floors, floor covering and sleeping quarters of pets. Repeat as necessary. **ANTS:** Spray trails, nests and points of entry. Hit as many insects as possible. Repeat treatment when necessary.

**TO KILL GARDEN PESTS LISTED ON FRONT PANEL:** Use spray with slow sweeping motion about 36 inches from all plants. Avoid wetting — a light spray kills pests effectively. Spray garden plants only when air is still. Spray in short bursts. Repeat application from time to time as long as insects are present. Use with caution on tender foliage, young plants and new growth. May injure plant species not listed on side panel.

**CAUTION:** Keep out of reach of children. Do not remain in enclosed areas after use. Ventilate the area before returning. Avoid contamination of food and food stuffs. Remove pets, birds and cover fish aquariums before using. Do not spray plants when temperatures exceed 90°F.

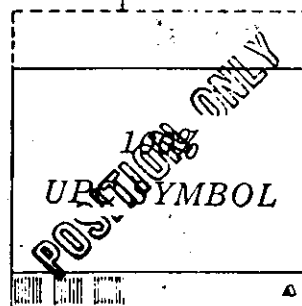
