The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1) Add the phrase "Use just enough repellent to cover exposed skin".
- 2) We note the addition of the sentence "Do not keep product on any longer than necessary". We believe this statement only partially complies with the intent of PR Notice 91-4. Add the phrase "After returning indoors, wash treated skin with soap and water".
- 3) For EPA Reg. No. 4822-197 and 4822-206, delete "Gives effective protection for the whole family" and "Provides hours of protection for the whole family".
- 4) For EPA Reg. No. 4822-239, note the correct spelling of black flies.
