Dear Ms Fugate:

The proposed amendments to the registration of the product cited above under The Federal Insecticide, Fungicide, and Rodenticide Act, as amended, revising the label in response to the DEET RED and adding optional label language and repellency claims and revising the Confidential Statements Of Formula (CSFs) are acceptable subject to the comments listed below:

- 1) Delete all references to the 8 hour repellency duration claim. The data submitted to support these claims has not yet been reviewed. Once the data has been reviewed and if found acceptabel, you can then request and amendment.
- 2) It appears now that there is no formula (basic or alternate) that does not contain a fragrance. Therefore the word, Unscented must be deleted from the product name.

This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.

Also, to be eligible for re-registration, the product must be packaged in containers utilizing a concave trigger to help aim the product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

A stamped copy of the revised label is enclosed for your

records. Submit two copies of the revised finished label before the product is released for shipment under this amended label.

The CSFs dated December 4, 2003 are acceptable and have been made a part of the file for this product.
