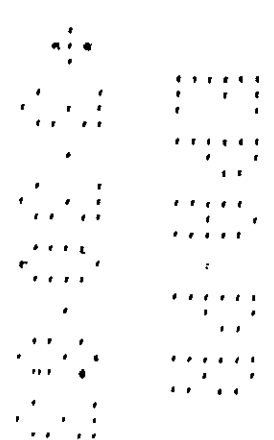

CAUTION

If swallowed get immediate medical attention. Note to physician: This product is a cholinesterase inhibitor. Atropine is an antidote and should be administered by injection only after symptoms appear. Do not apply to humans. Avoid contact with skin, eyes or clothing. Wash hands thoroughly with soap and water after use and before eating or smoking. Keep out of reach of children; do not allow children in treated areas until dry. Do not use in commercial food preparation areas or in edible products area of food processing plants. Do not apply to pets or contaminate feed, foodstuffs, dishes or utensils. Do not allow pets on treated areas until dry. Cover and avoid spraying fish aquariums.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Contains petroleum distillates. Do not induce vomiting. Get medical attention. IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists. IF ON SKIN: Wash with soap and water. Get medical attention if irritation persists or develops.

Shake well before using.

HOLD AS UPRIGHT AS POSSIBLE WHEN SPRAYING

Point spray nozzle toward surface to be sprayed and press button firmly. Hold container about 18" from the surface being sprayed. Spray until surface is wet.

ROACHES, WATERBUGS: Spray until wet in cracks around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

BEST AVAILABLE COPY

ANTS: Apply to ant trails; also around doors, windows and wherever ants enter house. Repeat as necessary.

FLEAS: Apply to infested areas such as pet bedding and resting quarters, around baseboards, door frames and wall cracks. Spray surfaces until wet. Old, soiled bedding of pets should be removed and replaced with clean, fresh bedding after spray has been allowed to dry. Do not spray directly on animal. Repeat as necessary. For best results pets should be treated with a flea control product, registered for animal application, to control the source of the infestation.

SILVERFISH, CRICKETS, MILLIPEDES, CENTIPEDES, SPIDERS: Spray areas infested by these pests. Repeat as necessary.

DISPOSAL: Do not reuse container. Wrap container and put in trash collection.
