TO KILL GYPSY MOTH CATERPILLARS: When trees begin to show leaves in Spring, or when caterpillars are first observed, place RAID TREE GUARD BAND around tree, approximately 5-6 feet above ground level. Hold container 4-6 inches away and spray exposed surface of band completely and evenly all the way around tree with RAID FORMULA 34 INSECT SPRAY. Do not apply spray directly on tree. Reapply every 7 days or as necessary. Reapplication after heavy rainfall is recommended. Continue treatment as long caterpillars are present.

TO AID IN PREVENTING REINFESTATION OF TREES: Use RAID TREE GUARD SYSTEM following the above directions.
