SHAKE WELL BEFORE USING.

HOLD AS UPRIGHT AS POSSIBLE WHEN SPRAYING.

Point spray nozzle in desired direction - at insect or toward surface to be sprayed - and press button firmly. Hold container 18" from the insect being sprayed. Spray insects directly where possible.

ROACHES, WATERBUGS: Spray directly on sight. Spray until wet in cracks around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

ANTS: Apply directly onto ants and ant trails; also around doors, windows and wherever ants enter house. Repeat as necessary.

SILVERFISH, CRICKETS, SPIDERS, CENTIPEDES, MILLIPEDES, EARWIGS, SOVBUGS: Spray directly on sight. Spray in cracks around baseboard, windows, under sinks, stoves, wherever insects hide. Spray insects directly where possible. Repeat as necessary.

FLEAS: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, windows and door frames and localized areas of where these pests are present. Old bedding should be removed and replaced with clean fresh bedding after treatment of pet area. To control the source of the flea infestation, treat pets with a product registered for animal application. Do not spray pets with this product.

DISPOSAL: Do not reuse container. Wrap container and put in trash collection.
