PHYSICAL CHEMICAL HAZARDS

SHAKE WELL BEFORE USING

HOLD AS UPRIGHT AS POSSIBLE WHEN SPRAYING.

Point spray nozzle toward surface to be sprayed and press button firmly. Hold container about 18" from the surface being sprayed. Spray until surface is wet.

ROACHES, WATERBUGS: Spray until wet in cracks around baseboards and other hiding places. When bugs are driven out, spray directly. Repeat as necessary.

ANTS: Apply to ant trails; also around doors, windows and wherever ants enter house. Repeat as necessary.

SILVERFISH, CRICKETS, SPIDERS, CENTIPEDES, MILLIPEDES, EARWIGS: Spray areas infested by these pests. Repeat as necessary.

FLEAS: Spray infested areas. Repeat as necessary. For best results treat pets with an approved flea control product registered for animal use to control the source of infestation.

STORAGE: Store away from heat, sparks or open flame, in an area inaccessible to children. **DISPOSAL:** Do not reuse empty container. Wrap container and put in trash.
