Raid Wasp & Hornet Killer III  
EPA Registration No. 4822-224  
Your Application Dated October 4, 1994

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), sec. 3(c)(7)(A), is acceptable provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
2. Make the following labeling changes before you release the product for shipment bearing the amended labeling:
  - a. Correct the chemical name of tetramethrin in the Ingredients Statement, ie. "...2,2-diethyl..." should be "...2,2-dimethyl..."
  - b. Delete the "Environmental Hazards" statement, including the instruction: "Do not apply directly to water." Since this product has very a very limited use pattern (specifically, spot applications to nests), it is not considered to be a "true" outdoor use and therefore does not require an Environmental Hazards statement.
3. Submit two copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

**DIRECTIONS FOR USE:** It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**FOR OUTDOOR USE ONLY.**

To kill paper wasps, yellow jackets, mud daubers, bald-faced hornets, and bees. For best results, spray in early morning or early evening when insect activity is minimal. Stand safe distance from nest and not directly underneath. Hold can as upright as possible while spraying. Point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill wasps and hornets which return to nest. Wait at least 24 hours before removing the nest. Do not apply to pets or contaminate feed, foodstuffs, dishes or utensils. Avoid spraying vegetation directly. Avoid excessive wetting of asphalt.

**STORAGE AND DISPOSAL STATEMENTS**

**STORAGE:** Store in an area inaccessible to children.

**DISPOSAL:** Do not reuse empty container. Do not puncture or incinerate. Wrap container and discard in trash.

*[Per PR Notice 94-2 the following Disposal statement, or a variation which does not alter its intent, may be used:*

**Disposal:** This container may be recycled in the few but growing number of communities where (steel) aerosol can recycling is available. Before offering for recycling, empty the can by using the product according to the label. (DO NOT PUNCTURE!) If recycling is not available, do not reuse empty container. Wrap container and discard in trash.]
