(For a complete flea control program, or for particularly heavy flea infestations, use Raid Fogger Formula V in conjunction with other Raid Flea Killer Plus products (Dog Spray, Yard Spray, Carpet and Room Spray).) SHAKE WELL BEFORE USE

KILLS: Roaches, fleas, ticks, spiders, flies, mosquitoes, wasps, hornets, yellow jackets, silverfish, ants, gnats, waterbugs, earwigs, palmetto bugs, crickets and small flying moths. Use Raid Fogger Formula V for bug (flea) infestations in HOUSES, APARTMENTS, ATTICS AND GARAGES.

1) (Extinguish) (turn off) (all flames and pilot lights) (ignition sources) [EPA Pre-Approved Pictogram 4 representing "NO flames or pilot lights"]. [EPA Pre-Approved Pictogram 3 representing "Unplug and turn off ignition sources"] Call your gas utility or management company if you need assistance with your pilot lights. Do not use fogger in small confined areas, such as closets, cabinets or under counters or tables [EPA Pre-Approved pictogram 2 representing "Do not use in

small confined spaces"]. Do not use in a room 5 ft. x 5 ft. or smaller, instead allow fog to enter from other rooms. Do not use more than one fogger per room [EPA Pre- Approved Pictogram 1 representing "Do not use multiple canisters in a room"]. Use of a fogger in an enclosed space (or use of more than one fogger in a room) may cause the product to explode, resulting in injury to people or damage to property. CLOSE outside doors and windows. Before You Fog:

- 2) Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. [EPA Pre-Approved Pictogram 5 representing "Remove or cover exposed food" REMOVE pets and birds, cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).
- 3) Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper or paper towels.

To Start Fogging:

- 4) SHAKE CAN WELL. (Break off and remove) (bend) tab on side of sprayer. Tilt sprayer AWAY from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place. - 5) Set fogger on covered stand. Vacate the treated house, individual apartment unit, or other structure immediately. (Fogging will begin in approximately #)(seconds)(minutes).) Fill out and place the hang tagon the door to the treated area to alert family and others with access to the treated area not to enter for 2 hours.

Airing Out:

6) Keep treated area closed and do not re-enter for at least two hours [Pictogram representing "Do Not Reenter for (Two) (2) Hours" (clock)]. Before reoccupying area, open all doors and windows and allow treated area to air for 30 minutes. [EPA Pre-Approved Pictogram 6 representing "Air out the room before entering"].
