The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Pyrethrins, PBO, and MGK264 RED, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

NOTE: This product is **not** yet being reregistered under section 4(g) of FIFRA.

Please note that the record for this product currently contains the Confidential Statement of Formulation (CSF) listed below. Any previously dated CSFs are superseded.

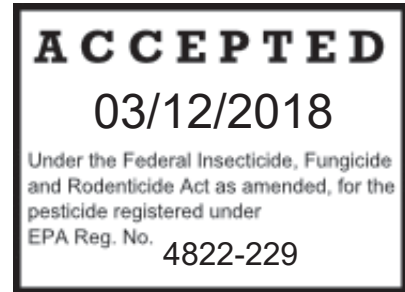



Before You Fog:




Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. REMOVE pets and birds, cover fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).

Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper or paper towels.

(A small amount of (clear)(colored)(name of color) material will be slowly released, indicating that the (timer has been activated) (time delay) (delayed action) (timer) (has begun)). Set fogger on covered stand. **Vacate the treated house, individual apartment unit, or other structure immediately.** (Fogging will begin in approximately #) (seconds) (minutes).) Airing Out:

Keep treated area closed and **do not re-enter for at least two hours.** Before reoccupying area, open all door and windows and allow treated area to air for 2 hours. If an odor is still detected additional ventilation is required. Treated surfaces may be slippery when wet.
