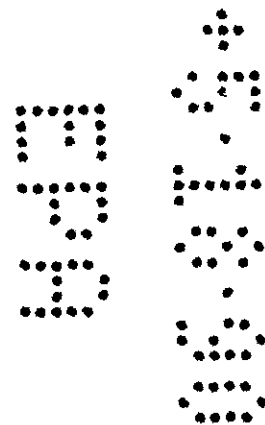

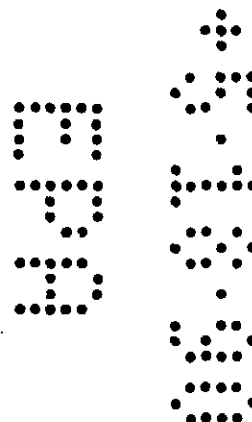
PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: May be harmful if swallowed or absorbed through the skin. Avoid contact with eyes, skin or clothing. Do not smoke while using. Wash thoroughly after handling. Avoid breathing spray mist or vapors. Keep away from food, feedstuffs and domestic water supplies. Remove pets and cover fish bowls (tanks) before spraying. Do not allow children or pets to contact treated surface until spray has dried. Note to Physician: Atropine by injection is antidotal only if symptoms of cholinesterase inhibition are present.

STATEMENT OF PRACTICAL TREATMENT IF SWALLOWED, call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by sticking finger down throat. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person. **IF ON SKIN,** wash thoroughly with soap and water. **IF IN EYES,** flush with plenty of water. Get medical attention if irritation persists.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of washes. Apply this product only as specified on this label.



DIRECTIONS FOR USE: It is a violation

of federal law to use this product in a manner inconsistent with its labeling. **SHAKE BEFORE USING.** Remove cap from bottle. Unwind sprayer hose and insert into bottle. Tighten screw cap. To prime sprayer, hold sprayer below level of bottle and squeeze trigger firmly about 10-15 times until product is dispensed. Adjust nozzle tip until desired spray is achieved. For storage, tighten nozzle tip securely.

ROACHES, WATERBUGS, CRICKETS, EARWIGS, SILVERFISH, FIREBRATS, SOWBUGS, CENTIPEDES, MILLIPEDES: Spray until wet in cracks, around baseboards, behind and beneath cabinets, refrigerators, sinks, stoves, around plumbing, and other localized areas infested with insects. Repeat as necessary. Do not spray on copper or brass.

FLEAS AND BROWN DOG TICKS: Apply to infested areas such as pet bedding and resting quarters, around baseboards, door frames and wall cracks. Spray surface until wet. Old, soiled bedding of pets should be removed and replaced with clean, fresh bedding after spray has been allowed to dry. Do not spray directly on animal. Repeat as necessary. For best results, pets should be treated with a flea control product registered with animal application to control the source of the infestation.

ANTS: Spray until surface is wet, applying to ant trails, around doors and window frames and wherever ants enter the house. Outdoors—thoroughly wet

hills and runways. Repeat application as infestations warrant and as reinfestation occur.

SPIDERS: Spray pests directly where possible. Apply to localized areas where infestations occur. Spray until surfaces are wet, particularly around windows, doors, baseboards and crawl spaces. Repeat as necessary.

CARPET BEETLES: Apply along baseboard edges of carpeting, under furniture under carpeting and rugs, in closet shelving where infestations occur or suspected. Spray surfaces until wet. Repeat as necessary.

STORAGE: Store in original container in an area inaccessible to children. Do not freeze. **DISPOSAL:** Do not reuse empty container. Wrap container and place in trash.
