Subject: Response to PR Notice 91-4 - DEET LIP Maximum Strength Deep Woods Off! EPA Reg. No. 4822-215 Maximum Strength Deep Woods OFF! II EPA Reg. No. 4822-216 Maximum Strength Pump Spray Deep Woods Off! EPA Reg. No. 4822-276 Submissions: October 30, 1991

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- Enclosed is a review done on #4822-215. In addition, we have other reviews on 100% DEET products that indicate the signal word should be "WARNING" rather then CAUTION. Please change the signal word to WARNING for all products identified above.
- 2) Change the Precautionary statements to read "HAZARDS TO HUMANS - WARNING: May cause eye injury. Harmful if swallowed." Keep remainder of those sections as given.
- 3) The statement "For deer flies, reapply every 3 hours" appears to be inconsistent with the PR Notice. Please review your data and either eliminate or revise this statement if reapplying every 3 hours increases exposure without sufficient need. (For product #4822-215)
- 4) Add the phrase "Use just enough repellent to cover exposed skin".

- 5) We note the addition of the sentence "Do not keep product on any longer then necessary". We believe this statement only partially complies wit' the intent of PR Notice 91-4. Add the phrase "After retrining indoors, wash treated skin with soap and water".
- 6) Fo EPA Reg. No. 4822-216, use the full name of the product wherever it appears in the labeling Deep Woods OFF II

We note that you have labeled these DEET products FLAMMABLE. This does not appear to be consistent with the reported flammability results for this ingredient. Please check your data. If there are other factors influencing this labeling issue, they should be brought to our attention. If not, the reference to FLAMMABLE should be removed.
