The proposed amendment to the registration of the product cited above under The Federal Insecticide, Fungicide, and Rodenticide Act, as amended, revising the label in response to the DEET RED and adding optional label language and revising the Confidential Statement Of Formula(CSF) is acceptable subject to the comments listed below:

1) Revise the Ingredients Statement to read:

ACTIVE INGREDIENT:
DEET.....98.11%
OTHER INGREDIENTS 1.89%

2) Revise the Precautionary Labeling to read:

Causes substantial but temporary eye injury. Harmful if swallowed. Do not get in eyes. Use of this product may cause skin reactions in rare cases. Wash treated clothing before wearing it again. Wash thoroughly with soap and water after handling.

This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.

Also, to be eligible for re-registration, the product must be packaged in containers utilizing a concave trigger to help aim the product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

A stamped copy of the revised label is enclosed for your records. Submit two copies of the revised finished label before the product is released for shipment under this amended label.

The CSF dated February 4, 2003 is acceptable and has been made a part of the file for this product.


