Dear Ms. Arrington:

S.C. Johnson & Son, Inc. (SCJ) hereby provides notification to the Agency of a minor revision to the labeling of the subject product pesticide. Specifically, we have added "TICKS-OFF®" to the list of optional marketing language. As this product already bears optional claims against ticks, we believe this to be a very minor rephrasing of existing claims and feel the modification falls within the realm of changes allowable via notification as outlined in PR Notice 98-10, Section II. N.(Other Revisions).

In a meeting with you, Richard Gebken, Marion Johnson, and Don Stubbs on March 6, 2007, our intended addition of TICKS-OFF was discussed, and it was communicated to SCJ that the Agency felt it appropriate to add this language via notification for those registrations where the master label already bears other ticks claims.

In accordance with PR Notice 98-10 we have included a completed Application for Registration and one (1) copy of the subject label. For your convenience the label addition has been marked in **bold Italics**. No other changes have been made to this label.
