## 1. Page 2:

- Within the First Aid Section
  - i. Add the following note to physician statement: "Note to Physician: Probable mucosal damage may contradict the use of gastric lavage." Refer to the source supplier's label for similar language.
  - ii. Remove the word "Skin:" from the beginning of the reaction statement. The DEET RED document did not limit allergic reactions strictly to skin.

- b. Within the section entitled "TO APPLY TO FACE", move the following DEET statements "Do not apply to children's hands." and "When using on children, apply to your own hands and then put it on the child." to the previous paragraph directly above. The DEET RED document does not limit this language when applying to the facial area only.
- c. Add the required header "Storage and Disposal" directly above the Storage and Disposal section. In addition, revise the sentence "Do not reuse this container" to "Do not reuse or refill this container."

## 2. Page 3:

- a. Within the "Hazards to Humans" section, revise the statement "Wash thoroughly with soap and water after handling." To "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco" <sup>2</sup>
- b. Within the section entitled "TO APPLY TO FACE", move the following DEET statements "Do not apply to children's hands." and "When using on children, apply to your own hands and then put it on the child." to the previous paragraph directly above. The DEET RED document does not limit this language when applying to the facial area only.

## 3. Page 4:

a. Add the required header "Storage and Disposal" directly above the Storage and Disposal section.<sup>3</sup> In addition, revise the sentence "Do not reuse this container" to "Do not reuse or refill this container."

To be eligible for reregistration, aerosol and pump spray formulations must be packaged in containers utilizing a concave trigger to help aim product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.
