CRAWLING BUGS: To kill Roaches, Waterbugs, Crickets, Silverfish, Centipedes, Ticks, Boxelder Bugs, Earwigs, Caterpillars, Millipedes, Spiders, Sow Bugs: Hold dispenser about 12 inches from surface being sprayed. Spray thoroughly into hiding places such as cracks, moist areas, openings around pipes and sinks, under refrigerators, baseboards and storage areas.

ANTS: Spray trails, nests, doors and window frames where ants enter.

FLEAS: Spray floors, floor coverings and sleeping quarters of pets. Repeat as necessary.

CARPET BEETLES: Spray top and underside of rug. Repeat as necessary.

FLYING BUGS: To kill Flies and Mosquitoes: Close all doors and windows. Direct the spray mist to all parts of the room especially windows and other light sources which attract these insects, staying about 3 feet from walls, fabrics and furniture. Fill room with mist then leave the treated areas. Keep room closed for at least 15 minutes. Ventilate the room when treatment is completed. Spray directly on stray Wasps, Hornets, Gnats and small Flying Moths that enter buildings.

GARDEN BUGS: Product is intended for use on ornamental garden plants only. It is not for use on edible crops. To kill Aphids, Climbing Cut Worms, Gypsy Moth Larvae, Japanese Beetles, Leafhoppers, Red Spider Mites, exposed Thrips, Webworms and Whiteflies on ornamental garden plants: Salvias, Roses, Azaleas, Chrysanthemums, Asters, Marigolds, Petunias, Begonias, Shrubs, Butterfly Plants, Dieffenbachia, Dracaenas, Ferns, Ficus, Palms, Pepperonia, Philodendrons, Piggyback Plants, Pines, Pothos, Spider Plants, Succulents, Evergreens, Fushias, Geraniums, Irises, Wandering Jews, Zinnias, Peonies,

Impatiens, Alyssums, African Violets and English Ivy. Spray when air is still and temperature is not above 90°F. Spray with slow sweeping motion 36 inches from all plants. Avoid wetting - a light spray kills pests effectively. Spray in short bursts. Repeat application from time to time as long as insects are present. Use with caution on tender foliage, young plants and new growth. For adult Whiteflies, Red Spider Mites, Gypsy Moths and Japanese Beetles be sure to direct spray to contact these pests. Thoroughly cover the infested area. Repeat as necessary.

STORAGE AND DISPOSAL

STORAGE: Store in an area away from heat or flame and inaccessible to children.

DISPOSAL:

Do Not Puncture or Incinerate!

Notification of minor label change per PRN 98-10

S.C. Johnson & Son, Inc. (SCJ) hereby notifies the U.S. Environmental Protection Agency that we are making a minor label change to the sodium nitrite statement based on the minor formulation amendment for two (2) alternate Confidential Statements of Formula with modified inert ingredients submitted on May 10, 2006. The submitted alternate CSFs have a slightly different amount (0.105% vs. 0.118%) of the inert ingredient Sodium Nitrite. Therefore we have changed the label statement to remove mention of a specified amount and instead list "contains sodium nitrite" as is required and referenced in the Label Review Manual, Ch. 5, VII, C. so that the statement will be accurate regardless of which formula is used. This change is consistent with and meets the requirements of PR Notice 98-10, section II, N, Other revisions. Also changing to "Other Ingredients" which is a non-notification per PR Notice 98-10, IV, F, 8.
