SHAKE BEFORE USING. Point spray nozzle away from face and press button, holding container as upright as possible.

TO KILL FLYING INSECTS:

FLIES, MOSQUITOES, SMALL FLYING MOTHS, GNATS: With RAID there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. Spray RAID up into the air with a sweeping motion, keeping about 3 feet from interior walls, fabrics, furniture, until room is filled with mist. Keep room closed for 15 minutes.

WASPS: Spray directly at stray wasps that enter building.

TO KILL CRAWLING INSECTS:

ROACHES, WATERBUGS, SILVERFISH, CRICKETS: Spray hiding places such as baseboards and floorboards, moist places, openings around sinks, drains and pipes, behind bookcases, cabinets and other storage areas, hitting as many insects as possible. Repeat as necessary.

ANTS: Spray trails, hills, around window frames and openings around pipes and baseboards where ants crawl, hitting as many as possible. Repeat as necessary.

SPIDERS, CENTIPEDES, SOW BUGS: Spray webs and places where these pests crawl. Hit as many as possible. Repeat as necessary.

CARPET BEETLES: Hit these bugs directly with spray on sections of floor, baseboards, shelves and underside of carpets. Repeat at frequent intervals.

BED BUGS: Spray baseboards, moldings, floorboards. Spray mattresses, particularly around seams and tufts. Take beds apart and spray into all joints. Repeat spraying at frequent intervals.

STORAGE: Store in an area inaccessible to children and away from heat or open flame.

DISPOSAL: Do not reuse empty container. Wrap container and put in trash collection. Do not incinerate or puncture container.
