Spiders, centipedes, sow bugs: Spray webs and places where these pests crawl. Hit as amny as possible. Repeat as necessary.

Carpet Beetles: Hit these bugs directly with spray on sections of floor, baseboards, shelves and underside of carpets. Repeat at frequent intervals.

Bedbugs: Spray baseboards, moldings, floor board. Spray mattresses, particularly around seams and tufts. Take beds apart and spray into all joints. Repeat spraying at frequent intervals.

Fleas: Spray floors, floor coverings and sleeping quarters of pets. Repeat spraying as often as necessary.
