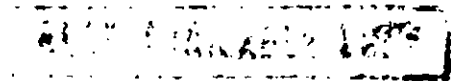

Thoroughly spray rugs and carpets where flea infestations are heavy. Put fresh bedding in pet's quarters after spray has dried. Additionally, treat pets with an EPA approved product registered for pet use. Use RAID Flea Killer Plus in conjunction with RAID Fogger for particularly heavy flea infestations for a complete flea protection program.

TICKS, SILVERFISH, CRICKETS, AND SPIDERS: Spray areas infested by these pests. Repeat as necessary.

CARPET BEETLES: Spray rugs and carpets especially around edges of the carpet and near baseboards. Spray directly into cracks and under carpets where insects may be found. Hit as many insects as possible. Repeat as necessary.
