2. Delete the claim "Cinnamon Sticks". This claim is misleading and may imply that it is a food grade product that may be used in food.

3. Submit two (2) copies of final printed labeling before you release the product for shipment bearing the amended labeling.

The proposed two alternate Confidential Statements of Formula dated October 9, 2000. (formula #27590 and Formula #27592) are in compliance with 40 CFR, Part 158.175, agree with the label and both CSFs are acceptable.

The Certified limits for the active and inert ingredients are in compliance with 40 CFR, Part 158,175 and are acceptable.
