Dear Ms. Rahn:

The following amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, to obtain approval for an alternate formulation and revise the product labeling, is acceptable.

- Alternate Formulation
- Five (5) copies of Product Labeling
- Administrative Materials

Acceptable Data

The requirements for PR Notice 91-2 were satisfied for the proposed Alternate Formulation, #29924, using the Old World Industries, Inc., is acceptable.

The upper and lower certified limits for both the active and inert ingredients were acceptable and all the ingredients utilized are cleared for use in pesticide formulations.

The alternate Confidential Statement of Formula, dated December 3rd, 2001, is acceptable only for the active ingredient sources from your list of actives having a nominal concentration of 98%.

The triethylene glycol from BASF must be deleted from the supplier list for Alternate Formulations # 29924 since its composition is 100% triethylene glycol. Triethylene glycol sources having a different nominal concentration must be listed on a separate list of suppliers.

Submit a new list for sources containing 98% of the active ingredient.

Make the following labeling changes:

Delete all references to "cars" and "autos". Your current set of use directions are inappropriate for these use sites.

A stamped copy of the labeling is enclosed for your records.

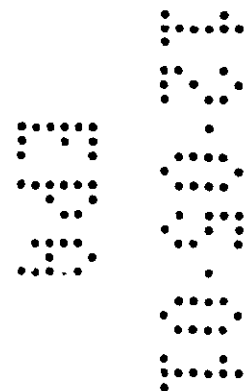

DIRECTIONS FOR USE.

It is a violation of the Federal law to use this product in a manner inconsistent with its labeling.

TO TEMPORARILY REDUCE AIRBORNE BACTERIA And eliminate odors in an average room (12' x 12' x 9'), close all doors, windows and air vents and spray product upward in center of room for 10 seconds.

For maximum effectiveness relative humidity should be between 45% and 70%. Resume normal room ventilation after spray has settled.

AUTOMATIC DISPENSER OPERATION:

1. Open the front door of the unit. Place thumb in front arrow on the right side of the front door and press firmly. Pull front door open to reveal air sanitizer can.
2. Keep aerosol can pointed away from your face. Do not spray in eyes.
3. "ON/OFF" switch is located inside the dispenser, just above the air sanitizer can. Turn switch to "ON", again while pointed away from face and eyes. Dispenser should release a measured amount of spray approximately 5 seconds after turning the unit "on" and then every 15 minutes for the next 3 weeks.
4. Close the front door.
5. Dispenser should be placed on a flat surface and directed where air flow will carry the air sanitizer spray throughout the room. Keep pointed away from face and eyes.

To Temporarily Reduce the Number of Airborne Bacteria: A measured amount of product will spray into the room at intervals to temporarily reduce the number of airborne bacteria. Within 24 hours of continued use, the air sanitizer will prove to be effective in temporarily reducing odor-causing bacteria. One unit should be installed for each average sized room (12' x 12' x 9'). Close all doors and windows. Spray should be directed where flow will carry the particles through out the closed area. Factors such as air current, temperature, humidity, and conformation of treated area govern number of units required for effective control.

For smoke and odor control: Automatic dispenser will spray automatically at regular intervals. If possible, remove the source of odor.

Storage and Disposal Statements

STORAGE: Store away from heat, sparks and open flame, in an area inaccessible to children. **DISPOSAL:** This container may be recycled in the few but growing number of communities where aerosol can recycling is available. Before offering for recycling, empty the can by using the product according to the label. (DO NOT PUNCTURE!) If recycling is not available, wrap the container and discard in trash.
