The acute toxicity studies in support of the subject product has been reviewed and we have the following comments:

1. The signal word is " CAUTION" and the toxicity profile is as follows:

- 2. The acute inhaltion study is classified supplementary data and must be reconducted. The study's deficiencies are as follows:
- a. The MMAD is too large. The Agency is currently accepting acute inhalation toxicity studies with MMAD between 1 and 4 microns. The MMAD reported in the study was over 12 microns.

  b. The individual particle concentrations (Table 4)
- b. The individual particle concentrations (Table 4) do not add up to 100%. In many cases their sums are not even close to 100%. This indicates that a large portion of the airborne particle mass was not measured, thus the MMAD and GSD are questionable.

- c. Their is a large variation between the particle concentrations determined analytically (6.6 mg/L) and gravimetrically (1.7 mg/L). No explanation for this variation was given. It is therefore hard to determine from these results, which of the two readings is correct.
- 3. A dermal sensitization study was not included in your submission. You must therefore, submit a dermal sensitization study performed with the subject product or cite a study performed with an identical or substantially similar formulation to your product.
  - 4. Make the following revisions on your label:
- a. Incorporate the following text under "Precautionary Statements Hazards to Human and Domestic Animals": ....... Harmful if absorbed through skin. Avoid contact with skin eyes or clothing. Wash thoroughly with soap and water after handling.
- b. Revise the Statement of Practical Treatment to read: If on Skin: Wash with Plenty of soap and water. Get medical attention.
- c. The label should identify this product as containing sodium nitrite.
