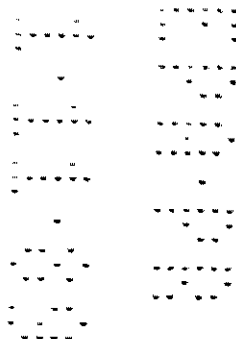

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR HOUSEHOLD USE: Hold container upright. Do not spray up into air. Apply to surfaces only. Point spray opening toward surface to be sprayed and press button firmly. Hold about 12" from surface being sprayed. Spray untill surface is wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials. Repeat treatment as necessary.

ROACHES, WATERBUGS: Spray until wet in cracks around baseboard and other hiding places. When bugs are driven out, spray directly.

ANTS: Apply to ant trails, also around doors, windows and wherever ants enter house.

SILVERFISH, CRICKETS, SPIDERS: Spray areas infected by these pests.

STORAGE AND DISPOSAL

STORAGE: Store away from heat or open flames, in an area inaccessible to children.

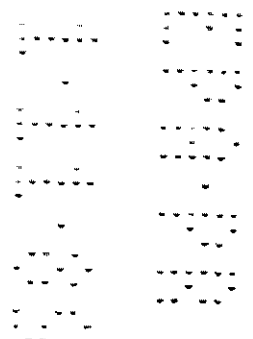
DISPOSAL: Replace cap and discard in trash. Do not puncture or incinerate.
