It is therefore understood that the non-pesticidal claim --"NEW COUNTRY GARDEN FRAGRANCE"--describes ornamental aromas, and excludes any implications to vegetables.

Keep room closed for 15 minutes. Ventilate room before reentering.

FLEAS: Remove soiled pet bedding and clean thoroughly or destroy. Spray sleeping quarters of pets, around baseboards, windows, door frames and floors. Spray rugs and carpets where flea infestations... occur. Repeat as necessary. Put fresh bedding in pet quarters after spray has dried. If used on light colored or delicate upholstery fabrics, test in an inconspicuous place prior to use. SPIDERS, CENTIPEDES, SOWBUGS: Spray webs and places where these pests crawl. Spray insects directly when possible. Repeat as necessary.

#### STORAGE AND DISPOSAL STATEMENTS STORAGE: Store in an area inaccessible to children. DISPOSAL: Wrap container and put in trash.


