Subject: Amendment - Label & Confidential Statement of Formula Addition of Dragoco Fragrance Raid Ant & Roach Killer 6 EPA Registration No. 4822-323 Your Submission dated December 22, 1992

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below.

- Delete the phrases "Country Fresh Scent", "Clean Fresh Scent", "Spring Fresh Scent" "Outdoor Fresh Scent". Statements relating to the non-pescicidal purpose of the product are not acceptable especially if they may give a false or misleading impression regarding use of the product. These phrases appear more appropriate for deodorizing products rather than pesticide products.
- The Confidential Statement of Formula of the above date has been reviewed and we need the following information: Please provide the chemical identity of all the components, the percentage composition, CAS Registry Number and Material Safety Data Sheet (two copies) for the Fragrance 716692-M2 by Dragoco. For perfumes and flavorings, provide for each component in the the chemical name, CAS Registry Number, and the percentage or range in percentage in the mixture. Certify that flavors are non-food type.

A stamped copy of the label is enclosed for your records.
