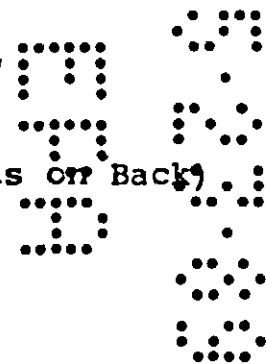

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

For outdoor use only. Do not use indoors or in poorly ventilated areas.

To kill paper wasps, yellow jackets, mud daubers, baldfaced hornets, and bees. For best results, spray in early morning or early evening when insect activity is minimal. Stand safe distance from nest and not directly underneath. Hold can as upright as possible while spraying. Point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill wasps and hornets which return to nest. Wait at least 24 hours before removing the nest. Do not apply to pets or contaminate feed, foodstuffs, dishes or utensils. Avoid spraying vegetation directly. Avoid excessive wetting of asphalt.

STORAGE AND DISPOSAL STATEMENTS

STORAGE: Store in an area inaccessible to children.

DISPOSAL: Wrap empty container and put in trash. Do not puncture or incinerate. Do not reuse empty container.
