Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1) Add the phrase "Use just enough repellent to cover exposed skin".
- 2) Add the phrase "After returning indoors, wash treated skin with soap and water". We have no objection to the statement "Do not keep product on any longer than necessary".
- 3) Change the Inert Ingredients total to 92.500%.

May damage furniture finishes, plastics, leather, watch crystals and painted or varnished surfaces including automobiles. Do not keep product on any longer than necessary. Do not use under clothing.
