


S.C. Johnson & Son, Inc. recently realized that the telephone number in the Disposal section of our registered labels needs to be corrected from 1-800-558-5252 to 1-800-529-3394. Stuart McArthur of SCJ contacted each of the PM teams involved in our various company registrations, Anne Sibold of PM 10, Linda DeLouise of PM 15, Tom Harris, and Jim Downing of BPPD to discuss how this might be accomplished procedurally, and each advised that this correction should be handled via notification. By means of this letter, we wish to officially notify the Agency of this minor change to the subject product label.

In a letter dated September 27, 2002 (see attached), Marion Johnson announced that in an effort to improve consumer awareness, DEET registrants would be allowed to permanently amend their labels via notification by utilizing the common name for DEET in place of the lengthier chemical name. SCJ wishes to take advantage of this opportunity and has revised the attached label accordingly.

To facilitate these changes we have enclosed a fully executed Application for Pesticide Registration and two copies of the revised labeling. For your convenience all revisions have been marked in ***bold Italics***.

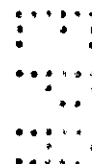
