- 1) Place the following statement in the First Aid section:

- 2) The following statements must added to the directions for use:

⌘Do not allow children to handle this product.⌘

⌘Do not apply to children's hands.⌘

⌘When using on children, apply to your own hands, and then put it on the child.⌘

- 3) Add the statement, ⌘Wash treated clothing before wearing it again.⌘, to the Precautionary Statements.

This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.

DIRECTIONS FOR USE

For best results, spread evenly and completely over all exposed skin. **Do not apply over cuts, wounds, irritated or sunburned skin.** Apply to hand for application to face and neck and rub on. Do not apply near eyes and mouth. **Apply sparingly around ears.** Use just enough repellent to cover exposed skin. **Avoid over-application of this product.** Frequent reapplication and saturation are unnecessary. Do not keep product on any longer than necessary. After returning indoors, wash treated skin with soap and water. Do not use under clothing. Do not apply on or near: acetate, rayon, spandex, dynel fabrics or other synthetics (other than nylon), furniture, plastics, leather, watch crystals and painted or varnished surfaces including automobiles.

STORAGE: Store away from heat or flame in an area inaccessible to children.

DISPOSAL: Before disposing, empty the container by using the product according to the label. Do not reuse this container. Place in trash or offer for recycling if available.
