- 1. In the bullets on pages 1 and 2,
  - a. remove the word "New" and the phrase "(and improved)" from all locations as these statements are only permitted for a period of 6 months;
  - b. remove the word "Powerful" from all locations; and
  - c. remove any reference to following diseases from the product label as they have been identified not to occur in the United States:
    - Japanese Encephalitis,
    - Cache Valley Encephalitis,
    - Venezuelan Equine Encephalitis,
    - Murray Valley Encephalitis,
    - Ross River Fever,
    - Barmah Forest Disease,
    - Dengue Fever,
    - Yellow Fever,
    - Rift Valley Fever,
    - European Tick Born Encephalitis, and
    - Onchoceriasis.
- 2. On page 2 under Precautionary Statements, change the sentence "Wash thoroughly with soap and water after handling" to "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet."
- 3. On page 3 in the First Aid statements,
  - a. remove the word "Skin:" prior to the sentence that begins "If you suspect a reaction to this product..." because the suspected reaction may not be limited to dermal symptoms; and
  - b. add the sentence "Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage."
- 4. On page 3 under the Directions for Use, add the sentence "When using on children, apply to your own hands then put it on the child" to the main Directions for Use section, per the DEET RED. This sentence appears in the "To apply to face" section of the directions for use, but the RED does not limit this statement to facial applications.
- 5. On page 4, include the header "Storage and Disposal" directly above the storage and disposal language per 40 CFR §156.10(i)(2)(ix). In addition, include the sentence "Offer for recycling, if available" in the Storage and Disposal language per 40 CFR §156.140(a)(3).

Also, to meet the requirements of the DEET RED, the product must be packaged in containers with a concave trigger to help aim the product, or another comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.

In addition, should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance. As an alternative, you may refer consumers to the company's phone number or email address.
