Subject: Label Amendment - Response to Agency's September 15, 2004 Letter Raid Yard Guard Outdoor Fogger Formula VII EPA Reg. No. 4822-394 Your Submission Dated May 6, 2005 __

Dear Ms. Naujock:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. The claims "Keep bugs OFF! without anything on" and "The Off that you don't put on" will be acceptable if you delete "without anything on" and "that you don't put on". As previously indicated we consider this a misleading comparison with other pesticides (40 CFR 156.10(a)(5)(iv). These same advertising claims should be deleted/modified on the labeling for EPA Reg. No. 4822-469. We regret we missed this in our original review.
- 2. Delete reference to "West Nile virus". As indicated in comment 1(a) of our September 15, 2004 letter these type claims must be supported with efficacy data or deleted.
- 3. Delete "Provides a bug free outdoor area for hours". See comment 1(c) in our September 15, 2004 letter.

SHAKE BEFORE USING

(Note to EPA Reviewer: This product can also be use in conjunction with an extension arm applicator/delivery system for ease of use. The following use instructions will appear on the extension arm applicator: "Inserting Can- Insert can into housing, placing "half moon" indent side of cap onto raised "half moon" shaped ledge of housing.")

(NOTE: The above graphics will not appear on the label when the product is used in conjuction with the extension arm applicator/delivery system since the can will have a different type of overcap.)

Direct spray toward area being treated. Point nozzle (applicator) (extension arm) away from face, other people, and animals. Hold can (applicator) (extension arm) on slight downward angle. For best results, spray when air is calm. Allow a few minutes for product to take effect. Spray articles in the area like foliage and legs of furniture in addition to spraying air and allowing to settle. Spray from center when not breezy. Spray with wind if breeze is blowing.

SPRAY FROM CENTER WHEN NOT BREEZY (graphic) SPRAY WITH WIND IF BREEZE IS BLOWING (graphic) SPRAY ON FURNITURE LEGS AND FOLIAGE* (graphic)

FLYING INSECTS: Flies, mosquitoes, gnats, small flying moths, wasps and hornets. Allow fog (spray) to drift over area. Direct fog (spray) toward bushes or grass from at least 4 to 6 feet away. Give special attention to breeding areas such as garbage cans and compost piles.

CRAWLING INSECTS: Ants, crickets, centipedes. Hold Can two (2) to three (3) feet from surface to be treated and spray infested surfaces of patio or picnic area, hitting as many insects as possible. Spray to slightly moisten the surface. Also spray legs of tables and chairs to repel ants and crawling insects. Spray ant hills for best control. *Keep 4 to 6 feet away from ornamental plants while spraying.

Read entire label before use

DO NOT APPLY TO PEOPLE OR PETS

Cover or remove exposed food. Avoid contamination of cooking utensils and food preparation surfaces. Do not use on edible crops. Kepp away from all open flames such as grills and candles. For outdoor use only as an aid in controlling these insects. SHAKE WELL BEFORE USING.

- 1. Tilt can top and sprayer away from face (container sprays straight up)
- 2. Bend tab on side of sprayer. Press down firmly on sprayer pad until it snaps into place.
- 3. Set can on the ground near center and slightly upwind of area to be treated and immediately leave the treated area.
- 4. For best results, use when air is calm.
- 5. Allow a few minutes for product to take effect.
- FLYING INSECTS: Kills mosquitoes, flies, gnats, hornets, small flying moths and yellow jackets. Allow fog to drift over area.

STORAGE AND DISPOSAL

STORAGE: Store in an area inaccessible to children. DISPOSAL:

Do Not Puncture or Incinerate!

If empty: This container may be recycled in the few but growing number of communities where (steel) aerosol can recycling is available. Before offering for recycling, empty the container (can) by using the product according to the label. If recycling is not available, place in trash.
