Dear Ms. Fugate,

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. The Agency's label notification team, has referred S.C. Johnson's proposed label modification to the Insecticides Branch for a full label review, and follow-up communications.

1. The use of the product attribute claim "OFF! Family Pack" may be used only as part of a packaging component for multi-pack retail units, and must not be affixed or displayed on the primary product label or package units in order to comply with Section V(B)(6) of the DEET RED which states the following:

"6. Child-Safety Claims All direct or indirect claims of child safety must be removed from DEET end-use product labeling in order for those products to be eligible for reregistration."

Otherwise this claim may be construed as an indirect child safety claim.

2. Change the statement "For Playing and relaxing outdoors" to the following: "For use while playing and relaxing outdoors."

3. This acceptance does not supercede S. C. Johnson's requirement to modify the label language, as outlined in the DEET RED published by the Agency in September 1998.

4. Section 4 "Size(s) Retail Container" section lists the container size as 2-12 ounces, but the label lists the "Net as "1-12 fl. oz." Future submissions should clarify this discrepancy. The label should also state "Net Contents" as outlined in 40CFR§156.10(d)(4). In addition, the last "Final Printed" label submission was received on April 10, 1995, and S.C. Johnson should update the Agency's files with current Final Printed labels for this product. [40CFR§156.10(a)(6)] The Agency also requires a print size no smaller than 6 point font [40CFR§156.10(a)(2)(A)], and a container size of 1-2 fl ounces. may not provide sufficient space to insure that this size criteria has



Hold container 6 to 8 inches from skin or clothing and spray with a slow sweeping motion. Do not use as a space spray. Use just enough repellent to cover exposed skin. Avoid overexposure. Frequent reapplication and saturation are unnecessary. Do not keep product on any longer than necessary. After returning indoors, wash treated skin with soap and water.

To apply to face: Spray palm of hand and rub on. Do not apply to eyes and mouth and do not apply to the hands of young children.

For maximum protection, spread evenly with hand to moisten all exposed skin.
