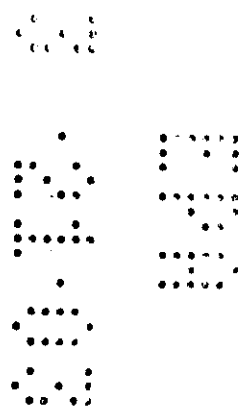

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **Read all directions before using this product.**

Hold container 6 to 8 inches from skin or clothing and spray with a slow sweeping motion. Do not use as a space spray. Use just enough repellent to cover exposed skin. Avoid overexposure. Frequent reapplication and saturation are unnecessary. Do not keep product on any longer than necessary. After returning indoors, wash treated skin with soap and water.

To apply to face: Spray palm of hand and rub on. Do not apply to eyes and mouth and do not apply to the hands of young children.

For maximum protection, spread evenly with hand to moisten all exposed skin.

**WORKS ON CLOTHING TOO:** Spray shirts, pants, socks, and hats. For chiggers also spray cuffs, socks and around other openings in outer clothing. Wash treated clothing. Do not apply under clothing. Will not damage cotton, wool or nylon. Do not apply on or near: acetate, rayon, spandex or other synthetics (other than nylon), furniture, plastics, leather, watch crystals and painted or varnished surfaces including automobiles.

Dear Ms. Edwards:

On October 22, 2002 S.C. Johnson & Son, Inc. submitted a notification for the subject product to add the following phrases:

Repels mosquitoes that carry West Nile Virus  
Repels disease carrying mosquitoes  
Repels disease spreading mosquitoes  
Repels mosquitoes that may carry diseases  
Repels mosquitoes that may spread diseases

In a letter dated November 15, 2002, you informed us that the submission did not meet the requirements of PR Notice 98-10 and would require further review by the Product Manager, Joe Tavano.

Since that time SCJ has had discussions with Joe Tavano and Marion Johnson. They have indicated that some, but not all, of our statements from the 10/22/02 submission would be acceptable to the Agency. They clarified that only certain specifically-worded phrases would be acceptable to the Agency, but that it was acceptable to add those statements via notification. Specifically, the statements we discussed are ***Repels mosquitoes that may carry West Nile Virus*** and ***Repels mosquitoes that may carry diseases***.

My means of this letter we wish to inform you of our intention to add those new statements to our product label. In accordance with PR Notice 98-10 we have enclosed a fully executed Application for Pesticide Registration and one copy of revised labeling. For your convenience revisions have been marked in ***bold Italics***.
