The amended label and Confidential Statements of Formula (CSFs) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, are acceptable. You continue to be subject to existing conditions on your registration and any deadlines connected with them.
