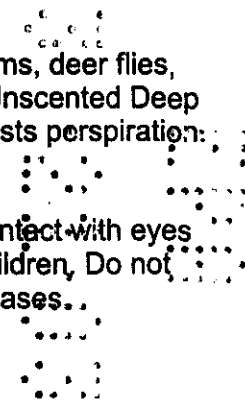

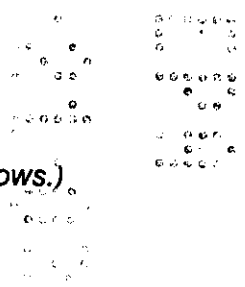

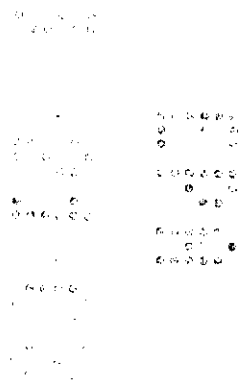

Notification of Label Change per PR Notice 98-10***

Dear Ms. Edwards:

On October 22, 2002 S.C. Johnson & Son, Inc. submitted a notification for the subject product to add the following phrases:

Repels mosquitoes that carry West Nile Virus
Repels disease carrying mosquitoes
Repels disease spreading mosquitoes
Repels mosquitoes that may carry diseases
Repels mosquitoes that may spread diseases

In a letter dated November 15, 2002, you informed us that the submission did not meet the requirements of PR Notice 98-10 and would require further review by the Product Manager, Joe Tavano.

Since that time SCJ has had discussions with Joe Tavano and Marion Johnson. They have indicated that some, but not all, of our statements from the 10/22/02 submission would be acceptable to the Agency. They clarified that only certain specifically-worded phrases would be acceptable to the Agency, but that it was acceptable to add those statements via notification. Specifically, the statements we discussed are ***Repels mosquitoes that may carry West Nile Virus*** and ***Repels mosquitoes that may carry diseases***.

My means of this letter we wish to inform you of our intention to add those new statements to our product label. In accordance with PR Notice 98-10 we have enclosed a fully executed Application for Pesticide Registration and one copy of revised labeling. For your convenience revisions have been marked in ***bold Italics***.
