Dear Ms Fugate:

The proposed amendments to the registration of the product cited above under The Federal Insecticide, Fungicide, and Rodenticide Act, as amended, revising the label in response to the DEET RED and adding optional label language and repellency claims and revising the Confidential Statements Of Formula (CSFs) are acceptable subject to the comments listed below:

1) Delete all references to the 8 hour repellency duration claim. The data submitted to support these claims has not yet been reviewed. Once the data has been reviewed and if found acceptable, you can then request an amendment.

2) It appears now that there is no formula (basic or alternate) that does not contain a fragrance. Therefore the word, Unscented must be deleted from the product name.

This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.


Also, to be eligible for re-registration, the product must be packaged in containers utilizing a concave trigger to help aim the product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

A stamped copy of the revised label is enclosed for your records. Submit two copies of the revised finished label before the product is released for shipment under this amended label.

The CSFs dated December 4, 2003 are acceptable and have been made a part of the file for this product.

**FIRST AID**  
 Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

Use just enough repellent to cover exposed skin and/or clothing. Avoid over-application of this product. Frequent reapplication and saturation are unnecessary. Do not allow children to handle this product. After returning indoors, wash treated skin with soap and water. **FOR MAXIMUM PROTECTION**, spread evenly with hands to moisten all exposed skin.

**TO APPLY TO FACE:** Spray palm of hand first and then apply sparingly and avoid eyes. Do not spray directly onto face. Do not apply near eyes and mouth. Apply sparingly around ears. Do not apply to children's hands. When using on children, apply to your own hands and then put it on the child.

**WORKS ON CLOTHING TOO:** Do not use under clothing. Spray shirts, pants, socks, and hats. For ticks and chiggers also spray cuffs, socks and around other openings in outer clothing. Do not apply on or near: acetate, rayon, spandex or other synthetics (other than nylon), furniture, plastics, watch crystals, leather and painted or varnished surfaces including automobiles.

**STORAGE:** Store away from heat or flame in an area inaccessible to children.

Do not puncture or incinerate!
