In accordance with PR Notice 98-10 we have included a completed Application for Registration and one (1) copy of the subject label.

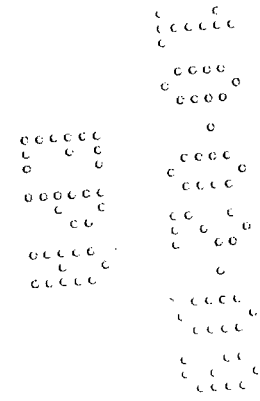

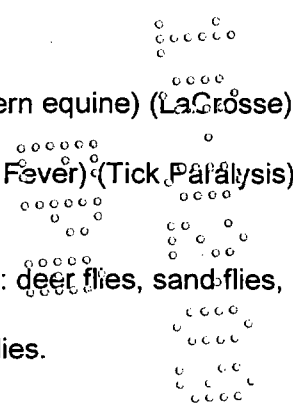
