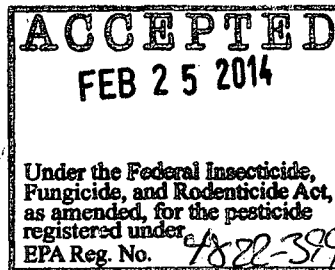

DIRECTIONS FOR USE
