DIRECTIONS FOR USE

TO APPLY TO FACE: Spray palm of hand and rub on. Do not apply to eyes and mouth and do not apply to the hands of young children.

WORKS ON CLOTHING TOO: Spray shirts, pants, socks, and hats. For ticks and chiggers also spray cuffs, socks and around other openings in outer clothing. Do not apply under clothing.
