This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA sec. 3(c)(5) or FIFRA sec. 4 when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling change listed below before you release the product for shipment:

- a. Add the phrase, "EPA Registration No. 4822-403."
- b. The statement "New Raid Ant & Roach water-based formula is the clean(er) way to kill bugs dead" and ". . . and no unpleasant (petroleum) odor" are unacceptable and must be deleted. Vague or unspecific claims implying unstated benefits or false or misleading comparisons with other products are unacceptable.
- c. The claims "New" and "Improved" may be used on the labeling for a period of 6 months following approval of the labeling.
- d. The claim "Now made with 2/3 less oil . . ." should be qualified with another S. C. Johnson Wax product. For example, "Now made with 2/3 less oil . . . than Raid Ant & Roach Killer X."

e. Add the following footnote to Permethrin below the ingredient statement:

"cis/trans isomer ratio: Min. 35% (±) cis and Max. 65% (±) Trans."

f. There should be asterisks for Piperonyl Butoxide Technical and the equivalent footnote.

g. The statement "For Household Use" should also appear beneath the product name.

h. Under the Physical or Chemical Hazards heading, change "120°F" to "130°F" to be consistent with 40 CFR 156.10 (h) (2) (iii).

3. The Confidential Statement of Formula dated October 21, 1993 for the alternate formulation is acceptable.

4. Regarding Product Chemistry we have the following comments:

a. It should be noted that the source products supplied in EPA Reg. No.'s 47932-1 and 24061-1 for Piperonyl Butoxide are equivalent to 90% of Butylcarbityl (6-Propylpiperonyl) Ether and 10% Related Compounds. Accordingly, the Piperonyl Butoxide from these two source products would be equivalent to 0.45% of Butylcarbityl (6-Propylpiperonyl) Ether of 0.05% Related Compounds which does not agree with the label footnote for Piperonyl Butoxide.

b. Storage Stability data for at least one year at ambient warehouse conditions must be conducted on the commercially packaged product determining the percentages of active ingredients at time zero and at three month intervals thereafter. The data need not be submitted to EPA unless one or more of the criteria cited in Paragraph II of PR Notice 92-5 have been observed.

c. The lower certified limit for Isoparaffin Solvent under Column 14b should be lower than the nominal concentration under Column 13b. The certified limits should be in agreement with MRID No. 42804-01 (page 28 of 28). Moreover, the certified limits for Fragrance RD-1436 should also agree with those specified in MRID 428704-01 (page 28 of 28).

4. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

ANTS: Apply to ant trails, also around doors, windows and wherever ants enter house.

SILVERFISH, CRICKETS, SPIDERS: Spray areas infested by these pests.
